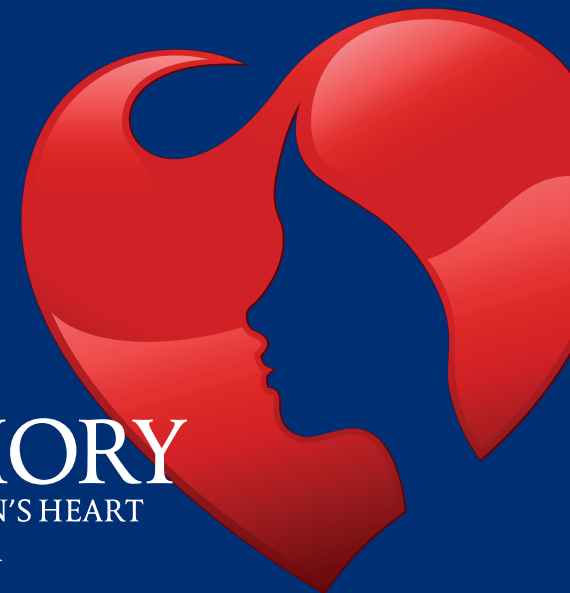

STATEMENT OF NEED

Women with polycystic ovarian syndrome (PCOS) have multiple risk factors for cardiovascular disease (CVD) including obesity, insulin resistance and dyslipidemia. According to data from the CDC, women with PCOS have 4-7 times greater risk of myocardial infarction compared with women who do not have PCOS. The conference will educate attendees on the increased risk of cardiovascular disease faced by women with PCOS and the importance of screening and aggressive management of cardiovascular risk factors in women with PCOS to reduce the risk for future development of CVD.

Hyperlipidemia is a well-known risk factor for CVD. However, hyperlipidemia in women can pose unique treatment challenges during different periods along the life cycle. Statin use is contraindicated during pregnancy, however, there are alternative therapies available for management of dyslipidemia during this crucial time including among those with familial hyperlipidemia. There is a need for increased knowledge among providers of the impact of menopause on a woman's lipid profile due to hormonal changes. Attendees will be educated on the need for counseling and shared decision making in the management of dyslipidemia among childbearing women with statins and non-statin medications.

OBJECTIVES

At the conclusion of this course, the participant should be able to:

- Understand the etiology and prognosis of peripartum cardiomyopathy
- Recognize the cardiovascular manifestations of fibromuscular dysplasia
- Discuss surgical and percutaneous options for treating chronic total coronary artery occlusions
- Explain the differences in lipoprotein levels across a women's lifetime
- Discuss the association between polycystic ovarian syndrome and cardiovascular risk
