PURPOSE

The last several years have witnessed the introduction of newer diabetes medications, as well as expanded indications for established medications. GLP-1 agonists and SGLT-2 inhibitors have new indications for reducing cardiovascular events and congestive heart failure hospitalizations, improving renal outcomes, and reducing body weight.

In addition, precision medicine is evolving to allow a more individualized approach to the management of diabetes, with therapeutic options based on our better understanding of the pathogenesis of type 2 diabetes. Our program will address these new and emerging management approaches for individuals with diabetes.

LEARNING OBJECTIVES

- Recognize the effects of GLP-1 agonists, SGLT-2 inhibitors and non-steroidal mineralocorticoid antagonists on diabetes patients with cardiovascular disease, heart failure as well as chronic kidney disease.
- Explain emerging approaches to individualized management of diabetes using precision medicine.
- Select the most appropriate therapeutic strategies for managing both type 1 and type 2 diabetes oral agents, injectable agents, insulins, insulin pump therapy and continuous glucose monitors.
